

By registering into a Sydney Uni Sport & Fitness ('SUSF') Social Netball Competition, you acknowledge that you have read and agree to the terms and conditions below. If you are a team captain registering on behalf of your team, it is your responsibility to ensure each team member has read and agreed to these terms and conditions.

PAYMENTS AND BOOKINGS

Please retain your receipt as proof of registration. A transaction fee applies to all bookings. By enrolling in any of our competitions you are choosing to accept this policy. Please choose carefully as we do not refund unless the competition is cancelled. SUSF accepts no responsibility for any changes in personal circumstances or work commitments.

If you wish to transfer competition, you must advise us in writing at least 10 business days before the start date of the competition in which you are enrolled. Space permitting, transfer is possible. A \$25.00 administration fee may apply. Bookings are only confirmed upon payment.

RELEASE

By enrolling, you agree that Sydney Uni Sport & Fitness is not responsible for any injury or loss caused by or to a person whether bodily or to property arising from the activities of Sydney Uni Sport & Fitness, its servants, agents or employees or from any person's alleged or actual acts, omissions, negligence or other event. By enrolling, each person accepts that when participating in a competition they do so on the voluntary assumption of risk on their own behalf. Participants are encouraged to seek medical advice from their doctor before enrolling in any competition which may result in physical injury. The team captain certifies that all team members are over the age of 18 or are under the direct supervision of a parent or guardian at all times.

INSURANCE

SUSF's Group Accident Insurance covers the following categories of persons:

- Current University of Sydney students;
- Current University of Sydney staff;
- Current SUSF Annual Members;
- Current SUSF Social Sport Members;
- Current SUSF volunteers and staff; and
- All current volunteers of the University of Sydney.

If you are not one of the above and you wish to be covered by the SUSF insurance policies, you must either sign up to full SUSF Membership or SUSF Social Membership online or using the QR Code's provided at the facility.

If you do not purchase a membership or fit into one of the categories above you will not be able to make an insurance claim.

All substitutes/fill-ins that play 4 or more games must become a SUSF Social Member. If a substitute/fill-in has played 4 or more games without a membership, the team may be penalised an/or disqualified. All players will be required to show ID in the finals to confirm their SUSF Membership status. Any player without a membership will not be allowed to play in the finals.

CREDITS

In some extenuating circumstances, SUSF may in its absolute discretion offer a pro rata credit. If you hold credit, please call us to redeem it on 1300 068 922. If you choose not to redeem your credit this way, and request SUSF refund you manually after you have paid any fees, a \$25.00 administration fee may apply. This also applies for any COVID related credits.

PRIVACY STATEMENT

SUSF (ABN 45 634 542 644) and its related or affiliated entities (including all affiliated clubs, programs and competitions) may collect personal information and health information from you in accordance with the *Privacy Act 1988 (Cth)* and other applicable privacy laws.

SUSF may collect personal information about you including CCTV footage and photographs. By signing these terms and conditions, you consent to SUSF:

- a) Collecting health information about you, including and medical, behavioural or additional needs or allergies that you have; and
- b) Using your personal information in order to contact you about our brands, products, services, special offers, promotions, newsletters, online surveys, fundraising campaigns, alumni events, news and competitions.

SUSF collects and uses personal and health information about you in order to:

- Provide you with services, operate our facilities and clubs, run our business and operations and fulfil our obligations;
- Communicate and manage our relationships with you;
- Maintain and update our records; conduct marketing activities;
- Carry out market data analysis, prevent or detect fraud or abuses, enable third parties to carry out functions on our behalf;
- Maintain and develop our business systems;
- Assess your readiness for physical activity/exercise, ability to participate in programs, general welfare and to provide you with medical treatments as required.

We may also use photographs of you for publicity and advertising purposes.

SUSF may disclose personal information about you to:

- Related entities and affiliates of SUSF (including clubs);
- IT system administrators;
- Medical and health providers who provide services to SUSF members or users of SUSF's services or facilities;
- Third party service providers and credit reference agencies or debt collection agencies if you default on payments due to or obtain payment from you.

You are able to request access to personal and health information held by SUSF about you and seek correction of such information. Please refer to the SUSF Privacy Policy on the SUSF website for information on how to do

this. You can also refer to the Privacy Policy for information on how to complain about a breach of the Australian Privacy Principles by SUSF and how SUSF will deal with such a complaint.

If SUSF is not able to collect the personal and health information set out above, we may not be able to process your enrolment, allow you to participate in netball competitions, deal with your enquiries or engage in the activities listed above.

VALUES

SUSF upholds the following values:

- Fair Play
- Respect of players, officials and spectators
- Providing a safe, competitive and social environment that is open to everybody

To uphold these values, players should accord to the following behaviours. If it is found that you are not abiding by SUSFs values you may be asked to leave:

- Abide by the rules set by the program, and do not act in any way to intentionally circumvent these rules.
- Respect the position of the umpire/referees and the decision(s) he/she makes
- Do not abuse any other player, official or spectator verbally or physically
- Do not act with overly physical contact towards other players or have any actions that could cause injury to another player

RULES

- Umpires are provided for all games. Abuse of and/or lack of respect for umpires or misconduct will not be tolerated and may result in exclusion of your team from the competition.
- Players must be over the age of 18 at the start of round 1 of the respective competition. Players aged 16 or 17 years at this time may be registered at the absolute discretion of SUSF, provided a parent/guardian is present and observing said player at every match).
- People under the age of 16 are not permitted to participate in the SUSF Social Netball Competition.
- Only players who have been registered with SUSF (socialnetball@sport.usyd.edu.au) and are Members of SUSF (via Annual Membership or SUSF Social Membership) may participate in the competitions for the team/s that they are registered with.
- Players must have played 3 or more games in the competition to be eligible to take the court in finals.
- Do not act with overly physical contact towards other players or have any actions that could cause injury to another player Your team may be scheduled to play at any time during the allotted timeslot.
- Jewellery is not permitted to be worn on court at any time in the competition. Tape is available upon request to tape medical bands and wedding rings. Studs that cannot be removed may also be taped but players must seek approval from the SUSF Social Netball Competition Court Supervisor before taking the court. It is advised that all taping be done before you take the court.



- Nails must be kept short. Manicure kits are available upon request.
- The first centre and choice of side will go to the first team fully assembled on court. If both teams are ready to go, captains will toss for the first centre.
- Teams that rank within the top two of their division, two seasons in a row will be promoted a division for the next competition. Teams that finish in the bottom two of their division will be invited to play in a lower division for the next competition.
- Please visit our website to view the official rules of the game, the SUSF Code of Conduct and the SUSF Social Netball Grading Policy.
- All players in each Team must sign-on on the sign-on sheet prior to each game. If all players are not signed on by the end of half time, your Team may be forced to forfeit the game (no charge applies).
- Fill-in players must sign a waiver prior to taking the court.

FORFEITS

- All forfeits must be confirmed by **5pm** the **business day prior** to your game by emailing socialnetball@sport.usyd.edu.au
- Any forfeit within the timeframe above (minus extenuating circumstances as determined by SUSF) will incur a **\$70 fine** to be **paid prior to the next game**. Any team that hasn't paid their fine will not be permitted to play their next game. A competition point deduction will apply. SUSF reserves the right to remove teams from competitions with outstanding fines.
- Teams receive two complimentary forfeits per season (if confirmed 5pm the business day prior to the game). After these complimentary forfeits are used, teams will be fined a \$70 fee for each subsequent game to be forfeited.
- If you play a friendly game with registered fill in players, a technical forfeit will be recorded and no fine or points deduction will apply.
- If you are more than 5 minutes late, no fine will apply and you will play a friendly game. A competition point deduction will apply.
